#### Declaration on Export Limitation EU Dual Use Directive No. 428/2009

In accordance with European Foreign Trade Legislation, Export List Appendix I (EU Dir. 2017/2268) of the EU Dir. 428/2009, the delivered goods are

### Declaration on Export Limitation Products of US Origin

### Declaration on Export Limitation EU Dir. No. 267/2012 – Iran Embargo

# Deliveries of goods to Iran are subject to the EU Dir. No. 267/2012 and require special export control.

There is an export ban for Iran at the moment for the following VEGA devices:

- Single flanges, fittings, welded adapters, tubes, piping made of or coated with nickel or nickel alloys with more than 40 wt.% of nickel. Only valid if these parts have a diameter of less than 100 mm. This also applies for installed products.
- Certain versions of the following devices: VEGABAR 14,S16,17,81,82,83,86,87; VEGADIF 65; VEGAWELL 52
- Circular seals and closures with an inside diameter of less than/equal 400 mm made of PTFE, PCTFE, Viton fluorelastomers. This also applies for installed products in individual cases.

As soon as we learn that the final destination is Iran, we will examine the inquiry/order with regard to authorization requirements or export bans in accordance with EU Dir. 267/2012. We will notify the ordered immediately of the results.
